5. I will conduct myself in a professional and courteous manner at all times and to remember that as a participant, I represent the United States of America and the USAWKF. I understand that the Delegation Leader, Team Leaders and Team Coaches are authorized to dismiss team members from the team who do not follow reasonable commands and instructions and/or showing disrespectful conduct to the officials of the 2009 USA National Sanshou Team Trials and/or Organizing Committee and/or teammates.
6. To be subject to penalties and sanctions for violations of rules and regulations, including but not limited to dismissal from the team and possible suspension from future participation in USAWKF sanctioned events.
